We carry on business of real estate in all ramifications and to act as estate/ property managers, developers, and corporate managers.

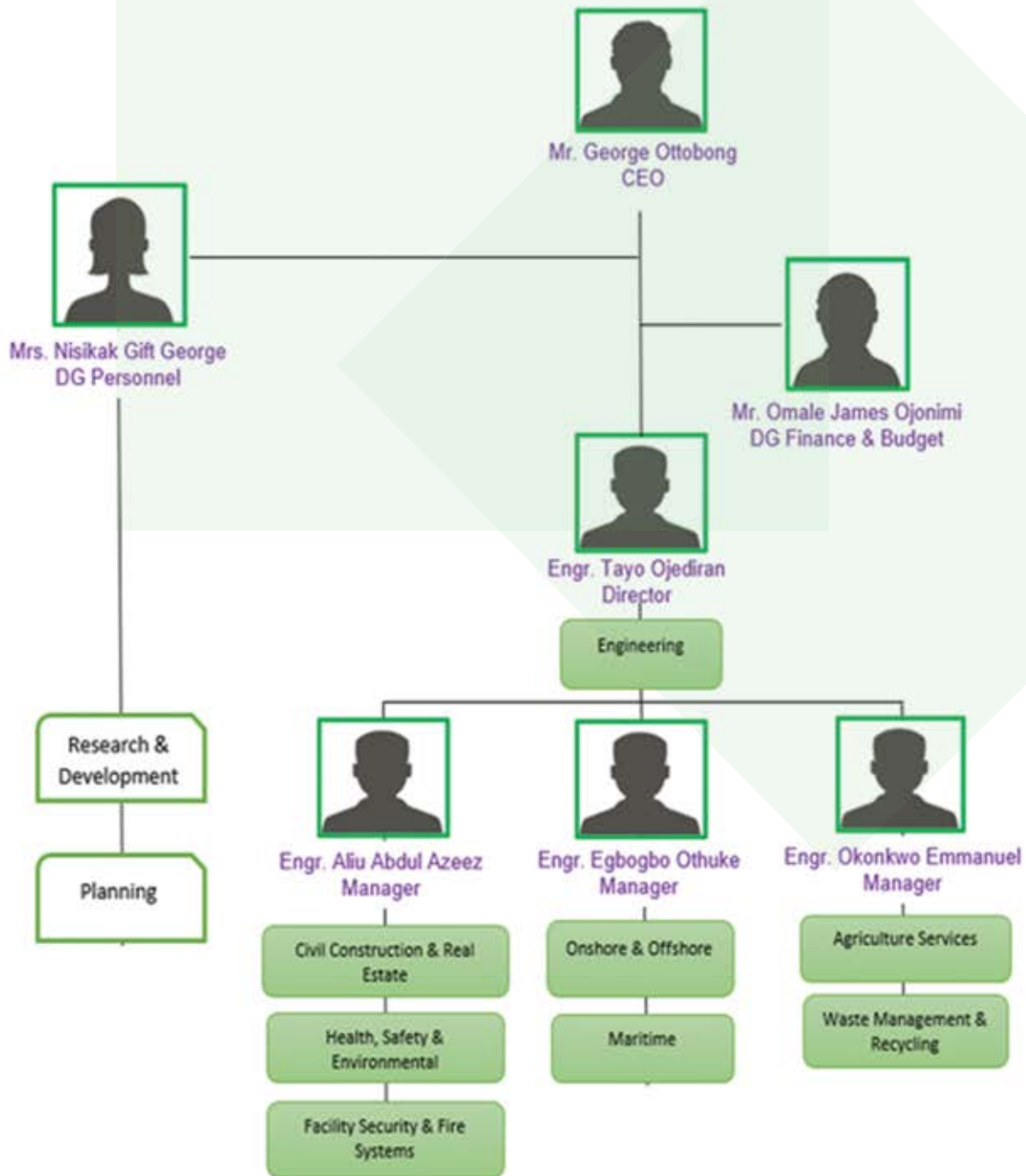
Manpower and General Contracting & Supplies.
